SECTION 2: No horses or Ponies shall be housed in the Village within 75 feet of anothers journing properties. SECTION 3: A fine of \$ 50. be levied against the owner if their animal leaves

manure on the streets.

SECTION 4: Unlawful to ride horses or ponies on public side walks nor on private properties with out owner express consent.

SECTION 5: Any horse or ponies or drawn vehicle must be under complete control of owners or handlers at all times while on Village streets.

SECTION 6: They shall conferm to all vehiclw traffic rules an regulations. SECTION 7: Any person charged with above violations shall be subject to a fine of \$ IO. and not to exceed \$50. with exception of section 3 which carries a

\$ 50. fine. SECTION 8: Permission may be granted on special occasions by the Mayor. This ordinance shall be read 3 times before passing.

This ordinance seconed by Hilyard. Vote: Folk yes, Hilyard yes, Hedrick No, Davis substained, Wharton substained.

Another discussion and Hedrick with drew his vote of No and voted yes. At this time the ordinance passed.

Mayor Barnes discussed the sewage. Motion by Wharton and seconed by Hilyard that Clarence Hunter be contacted and see if a right away could be had on his land for the sewage purposes. All voted yes.

A letter read from Columbia Cas stating the gas rates would be increased (eighty-four hundreds of a cent) per IOOO cubic feet effective with all bills rendered on and after Oct Ist, 1973, and an additional (four and three hundredths cents) per I000 cubic feet effective with bills rendered on and after Oct I4, 1973.

The Public Water Supply Grant Program discussed. The water board members voted to spend up to \$ 1000. for an engineer survey of the water system and land for availablaity for the purpose of meeting E P A requirements and to enable us to apply through the Public Supply Grant Program Information. These services to be performed by Dumond an Sifford an Associates. This action to be taken with the approval and support of the Village council. Reading of the minutes of October Ist approved as read.

Cene Carrett met with council and asked council to approve Ed Spangler, George Wharton, Ed Schooley, Mike Julian, Kenneth Smith, Pat Gilfillen, and Don Simpson as vol firemen. Motion by Folk that the men be approved and accepted by the council. Seconed by Hilyard. All voted yes. Carrett alsp stated the Village fire truck pasted the test.

Mr Sifford met with council. He stated the map for the water works had partly been completed. He discussed the land at the well house and stated the Village should acquire as much as they could. He stated that gas masks should be bought and used at the well house when they were working with the chlorine. He stated the Village should be pumping IOO gal per minute for the number of customers. Board Members Fraft, Hedrick, & Waits were present. He stated that for the land, new building, new filter, seperate building for chlorine it would amount to about \$ I00000. The Village cost of this would be \$ 50,000. After discussion Hedrick made a motion that the Village accept the data that was presented by Bifford and for him to start on this. Seconed by Hilyard. Vote: Hedrick yes, Hilyard yes, Davis yes, Folk yes.

The burning of leaves and other refuse discussed. Some of the members

had attended a meeting at Nelsonville concerning this problem. They said the Village could pass an ordinance prohibiting the burning if they so desired. A long discussion and no action taken.

Whedrick discussed the streets and the Van Camp bill. He stated that this bill be paid tonight, even tho the job was not done satisfactory.

A letter read from Amanda Bent Bolt stating that the alley would be opened this month an would be maintained by Bent Bolt. The letter also asked approval of a yellow line on the west side curbing starting at North end of their property and running a total of 30 feet south to provide a parking place for company vehicles directly in front of the office entrance and will assure the vehicles availability in the event of an emergency.
