The regular meeting of Village council met on this date with Brown, Thompson, Julian, Barr, Davis and Hedrick answering roll call. Mayer Christy in charge.

Reading of the minutes of February 5 approved as read.

Julian discussed some street repair stating the alley at Speakmans had been graveled and at the school the gravel had been hauled in but not spread. He also discussed the fire burner at Larry Kennedys stating that Mrs Dix had called him about it saying the garbage truck could not get around it. After discussion the council members said they would try and see the garbage man when he was in town and this was tabled until next meeting.

A discussion on the funds in the bank. Motion by Julian that the Nationwide Ins bill of \$ 98.00 and Treas of Fairfield Co bill of \$ 6.29 be paid tonight and the rest of the bills be tabled until later due to the lack of funds. This was seconded by Hedrick. Vote- Julian yes, Hedrick yes, Davis yes, Thompson yes, Brown yes, Barr yes.

Mayor Christy reported on the Police. He read a letter from the solicitor, Hastings stating that when funds become available all back pay can be paid to Police officer Doyle Nye. He also read a letter from the school by Carpenter and that letter thanked the Police department for the services at the school doing school activities and the dances held there. Mayer Christy stated that Fred Williams was not attending the Police academy school in Lancaster. Nye met with council and discussed the breaking and entering of Helser hardware and Strayers drug store. He stated there were some clues but not any thing that could be proven as yet.

Nye stated that the Lions club were going to sell breems at a later date and would like permission for them to canvas the town with them. Motion by Julian seconded by Hedrick to give them permission to canvas the town to sell their breems. All voted yes.

A discussion on the council chambers room for the use of bake sales and other activities. Motion by Hedrick that any one interested in using the room to contact the Clerk in advance if possible and permission granted, seconded by Julian. All voted yes.

Mayer Christy discussed the railroad track stating that he had talked with a man about it and he said care would be given to it.

Mayer Christy discussed the junk cars at the John Frank house as stated in February minutes stating that one was not paid for and as seen as it was it would be moved away and the other one would be repaired as seen as possible.

Hedrick discussed the street sign at High and N McKinley stating that Ames Valentine had cut it off when he moved the house on the lot and did not replace it like it was. After discussion motion by Brown that Valentine be given a 30 day notice to replace the sign as it was before. Seconded by Thompson. All voted yes.

The Board of Health meeting was held today in Lancaster was attended by Kuhn and was discussed.

A letter was read from the Columbia Gas of Ohio stating that on March 1, 1968, the gas rate would be decreased 1.54 cents per 1000 cubic feet.

Paul Dumond met with council to discuss the sewage. He stated that he was still trying to get a lean but it was very hard to get unless an option on some land was available. He stated that he had talked to Mr Butterbaugh about some land and he would sell one acre for \$ 5000. A discussion followed. Some land on the Kinser farm discussed. Davis stated he would contact Kinser and see if any land could be obtained from them.

Victor Yeung met with council. He stated that the Amercian Legion and the Fire Department would like to have permission to have and held a 4th of July celebration in the village and would like the use of school street from Wednesday noon July 3rd thru July 4th asking if the street could be closed to the public. He stated that they would have prebably 3 rides plus other concessions- a parade and fireworks in the evening. After discussion Hedrick made a motion that the Amercian Legion and the Fire Department be given permission to hold the celebration and be allowed to use school street for their celebration, providing there are no holes cut in the street or damaged in any way

and after the celebration the street to be cleaned up by them. This was seconded by Brown. All voted yes in favor. Mr Yeung stated that if there were any damages to the street they would take care of it and they would also clean every thing up after the celebration.

Mr Yeung also presented a letter to council which was read in regards to the removal of alleys from the town plat. These alleys are north of him and have never been used. The alleys is in the Simmens addition adjoining the north property line of lots 140- 141- 142 and 143 and preceding east to west. The alley adjoining the property line west of lot 143, beginning at West High street and preceding north to above alley. A discussion followed and council asked the Clerk to take the letter to the Solicitor Hastings and see how it could be done.

The Auditors Messenger dated January/ February 1968- Vol XII- No s I and 2 was read in regards to traffic lights and signals. It so stated that the Village may not spend that portion of gasoline and motor vehicle tax monies segregated as prescribed by Section 5735.28, Revised Code, to purchase, erect, or maintain traffic lights and signals on state highways. To the village this means the traffic light expense must be paid from the general fund.

Nothing further brought before the Board upon motion by Hedrick, seconded by Julian the meeting adjourned.

The regular meeting of Village council met on this date with Hedrick, Thompson, Davis, Barr, Julian, Brown answering roll call. Mayer Christy in charge.

Reading of the minutes of March 4 approved as read.

Mr Baker representing the Columbia Gas of Ohio met with council to discuss the gas lines and asking if any street repair to be made. He stated a mile of line would be replaced and it would be a new supply line.

Julian discussed the street stating that Kinser was patching some streets. He stated he had talked to the refuse man about the fire burner at Mrs Dix's and the refuse man would see if he could get around it and let Mrs Dix know and she would inform council.

Hedrick discussed the 15" main sewer that is broken down at the Johnson filling station on Main street. The sewer had been found broken by the man that took out the gas tanks. A discussion followed and no action taken.

Davis stated that Dumond came out and they went down to the Kinse farm and it would be favorable for an option for the sewage. No action taken.

A discussion on a sewer in the alley between Main and Church streets that should be put in to drain the water from Lawrences, Garretts, Hutchison, Speakmans, Bushee and Heslers. After discussion council members stated that an estimate would be get in the near future.

Junk cars in the Village again discussed. Thompson stated that the man living in the Frank house had not done anything about his. Mayer Christy stated he had been to see him and he would see him again. Five junk cars on the Strayer lot discussed. Hedrick stated he would see Buddy Bates about them and not to send him notice to move them out. Junkers at the Roger Auberry's discussed. Council members asked the Clerk to advise him by mail to remove them and give him a 10 day notice to do so.

Discussion on the funds. Seconded by Davis. Voted- Julian yes, Davis yes, Barr yes, Thompson yes, Brown yes, Hedrick yes.

Motion by Julian that the Clerk send letters to the South Central Power and the Columbia Gas telling them their bills will be paid sometime in May if possible. Seconded by Barr. All voted yes.

Eugene Garrett met with council and presented Charles Parker as a new fireman for the Amanda Village. Motion by Hedrick, seconded by Julian to accept him. All voted yes in favor.

Nye met with council and stated he had 3 flat tires on the cruiser and the plugs would not hold in them and he had a tube put in one of them and stated he might have to have another tube put in another tire. He stated that Dale Kennedy had helped him when Mr Pontius was buried. Motion by Julian, seconded by Hedrick to send Kennedy a thank you letter. All voted yes.

Mayer Christy asked Nye to work the radar on west Main street west of R R track.

Davis discussed the house numbering project. Julian stated that as yet it had not been rechecked. Mayer Christy asked Thompson to work with Julian on it and have it at the next meeting.

The Ditch Dredging fund discussed. At the time Hastings had told Davis that it was legal and if the \$ 15. tapping was not paid it could be added to their taxes. Council members asked the Clerk to go in to Hastings and check it out and see what the first step is.

The regular meeting of Village council met on this date with Barr, Davis, Hedrick, Thompson, Julian, Brown answering roll call, Mayer Christy in charge. Reading of the minutes of April 1 approved as read.

The Village Solicitor Lawyer Hastings met with council. Council members discussed with him several problems. The Ditch Dredging project was discussed and Hastings stated that the remainder that had not been paid by the people using the ditch could not be collected in any way from them because the project had not been done by law. He stated that the Village should buy the ELLIS MUNICIPAL CODE BOOK and that book would cost us \$ 40. A letter was read from the Mid-West and they stated that they would grade and pave Lutz ave from in front of the Mid-West office east to Scheel street if a storm sewer would be put in by the Village and it perhaps could be charged to the property owners using the sewer. Hastings stated that the first step on this would be to have an Engineer check this out and find out what it would cost as the Village would have to pay for all alleys and intersections if the Public paid for the sewer. Bad sidewalks discussed and Hastings suggested that the Insurance company should be checked to see if we have liability on sidewalks. Hastings discussed the funds with Council and stated that the money that was in the Police car fund could be put back in the General fund since it all came from it.

Julian discussed the house numbering project as he stated he thought it was done. After discussion Hedrick stated that he would go out with him and it would be re-checked. This was tabled until school is out so Hedrick would be free to do so.

Julian stated that Larry Kennedy had moved the trash burner as stated in March minutes and the refuse truck could get thru.

Larry Mets with the Circleville Refuse company met with council to discuss a performance bond or a contract. After discussion Mets stated that if a contract was drawn up by the Village he would sign it if it was in order for his specifications.

Mayer Christy discussed the Police stating he had collected \$ 69.40 in fines and costs for April. He stated the Sheriff had stated to him that there were no mutual aid between them and the Village. He stated he had contacted John Dupler and the insurance would take care of the Crusier and Police if it was on call duty and there was an accident.

The car with out license plates that is parked at Rhymers garage discussed. Mayer Christy advised Nye to notify the owner Mrs Saurbier and give her a couple of days to get it off the street and if it was not moved in that time have it pulled away.

A letter was read from the Columbia Gas of Ohio stating that the Village would have a cut of 2.31 ¢ per 1000 cubic feet of gas effective June 1st.

The traffic light discussed. Daryl Fouch Electric from Lancaster had been out and serviced it and the bill was \$ 66.25. Julian stated that he would service it every 6 months and the cost would be around \$ 5. plus parts that might be needed. Julian made a motion that he be given the authority to keep it serviced, seconded by Brown. All voted yes in favor.

He stated that he thought the company would stand the expenses.

Hedrick discussed the vacant lot owned by John Hartman across from Bob Davis. It needs mowing. Motion by Julian that he be sent a 10 day notice to have it mowed or the Village would have it done and it would be added to his taxes, seconded by Thompson. All voted yes.

Mayer Christy stated that Wayne Weeten was going to move his trailer and permission had been given him in 1967.

The water leak on Scheel st discussed. Council members advised the Clerk to notify the Beard by letter to have that repair made as soon as possible.

The storm sewer odors from the three storm sewers on scheel st discussed. Hedrick stated that Desdrant Blocks could be put in them to kill the odors and they would cost around \$ 30. each. and would last 6 to 8 months. Motion by Julian that the Village buy three and put them in. Seconded by Barr. All voted yes.

A letter was read from Lawyer Kistler in regards to the back flow of water into Helen Abbetts basement. A discussion followed and Mayer Christy said he would talk to Hastings and the Clerk answer Kistlers letter and tell him the Village was checking on this matter.

Letter from Gas co read stating that on July 16 the gas rates would be increased .38¢ per 1000 cubic feet.

Ordinance 3-68 pertaining to abanened certain alleys had its 2nd reading.

Motion by Hedrick to put the Police car fund of \$ 1050. Plus \$ 63. interest, in the general fund so the Police dept could be operated. This was seconded by Julian. All voted yes in favor.





The regular meeting of Village Council met on this date with Davis, Folk, Thompson, Hedrick, Barnes, and Julian answering roll call.

Mayor Christy in charge.

Reading of the minutes of July 6th and 12th approved as read.

Mr and Mrs Sanders of near Toledo met with council to discuss setting a trailer. They stated that they were going to try and buy the lot from Edith Vangundy on West High Street and if so they were going to tear down the old house and place the trailer there. After discussion motion by Barnes that Council give them permission to set a trailer on that lot if all specifications are met that are required by council. Seconded by Hedrick. All voted yes in favor.

Barnes discussed the water that was running after rains from the alley to the back of Elsie Dicksons store and causing a ditch, stating that Elsie would like to have it fixed. After discussion motion by Barnes that this be corrected by putting in another sewer to take care of the water. Seconded by Thompson. All voted yes in favor.

Mr & Mrs Gene Dupler met with council to discuss the gas line that Brewers had torn up and also the high place in the street that was left unfinished. A discussion followed. Folk made a motion that the gas company be notified by letter asking them if they would put in a new gas line and run it to the corporation line replacing the old line that was there and not tear up the new street, and to this motion he added that if the gas company would not do this the Village would take care of this for Duplers. This was seconded by Davis. All voted yes in favor.

Motion by Barnes that Brewers be contacted and ask them to fix the drop off on the street to a normal drop made with aprons and the street be improved east to the corporation line. This was seconded by Hedrick. All voted yes.

The Brewer bill was tabled until the work was completed to council approval.

The purpose of this meeting was to discuss the water department needs. The 99 year lease at the wells were read and discussed. Hastings said he thought the best would be to see if Young would sell a track of ground in and around the wells. A discussion followed. Hastings again suggested that the members go down to the well house and stake around # I well shed where the filter should be put in and then maybe Young would contact his Lawyer and then the Village could get some action of what he will do.

Julian made a motion that the council ask the water board to go down and stake out at # I well house and then approach Young and tell him that there will be a new filter put in and if any damages done the water board will pay him, and if he is not satisfied for him to contact his lawyer as soon as possible and it will be taken up thru the Lawyers. Seconded by Folk. All voted yes.

The gas and water lines damaged by Brewers when Lutz ave repaired was discussed. Thompson had contacted the gas company and he stated they were going to replace the gas lines. Julian stated that Brewers would like to have an estimate of their damages done to the lines. After discussion Council asked the Clerk to send Brewers a bill for damage for \$75.00 for damage to the water line and \$ 25.00 bill for damage to the gas line.

The regular meeting of Village council met on this date with Davis, Folk, Thompson, Hedrick, Barnes an Julian answering roll call. Mayor Christy in charge.

Reading of the minutes of August 2nd an 23rd approved as read.

Larry Brunstal with Nationwide Ins met with council to discuss our policy which expires Sept 7th. He stated that all rates were up and stated our package deal would cost us \$ 729.00 for coming year. The rate on the tar truck discussed. He stated the insurance on it was \$ 84. and by deducting that the rate would be \$ 645. After he left Mayor Christy discussed the rates from the State Automobile Ins which Dean Mets had figured for us. Their package deal was \$706. At this time he was contacted by phone and he stated that the insurance on the tar truck would be around \$ 95. to \$100. With this amount deducted from the deal it would cost the Village around \$606. to \$621. After discussion motion by Barnes that the tar truck insurance be dropped and the State Automobile Ins bid be accepted as long as the yearly premium does not exceed the maxium of \$611. This was seconed by Davis. Vote: Barnes yes, Davis yes, Julian yes, Folk yes, Hedrick yes, Thompson yes. The policy to be write to start on Sept 7th when the other policy expires. The payments to be 40% when policy is wrote -amount \$245. and 30% due Dec 7th amount \$ 183. and 30% due Mar 7th amount \$ 183.

Wooten met with council and stated that #1 well had been staked out for a filter and he had contacted Young and Young stated to him that they could not do any building there and he wanted no trespassers. Wooten stated he would call Hastings an see what the next step should be. Wooten asked council members for a raise for water board members. Motion by Folk that the salary of the water board members be raised from \$100. to \$200. per year starting January 1972. Seconed by Barnes. Vote: Folk yes, Barnes yes, Julian yes, Davis yes, Thompson yes, Hedrick yes.

Mayor Christy discussed Mrs Adler and stated that he had her hauled a load of dirt for a fill in front of her house. This was a project that was voted on to do a year ago. The spreading of it discussed. Barnes stated he would see that it was spread for her.

Mayor Christy discussed the option that Dumont had drawn up between Kinser an the Village. It was not acceptable to the Village or Kinser.

Bob Shupe met with council to discuss the dogs stating they were a nusiance with there all time barking and he would like to have something done. Council asked him to sign a waiver declaring them a nusiance and at this time he did so. Mayor Christy stated there would be something done.

John Bickham met with council to discuss the regional planning. A discussion followed. Mr Bickham stated he would get more literature for the members. Motion By Hedrick that this be tabled until more literature is received. Seconed by Barnes. All voted yes.

Julian stated the Village needed some sign posts. Motion by Barnes that one dozen be purchased now. Seconed by Folk. All voted yes.

Mayor Christy stated he had collected \$98. in fine money and was going to turn it in tonight.

Nye had turned in 110 hours for police duty and his hours were discussed. Motion by Barnes that the Chief of Police hours be increased 40 hours per month starting with Sept salary thru Nov salary if it will be legal and also if the finances are available. Seconed by Hedrick. Vote: Barnes yes, Hedrick yes, Julian yes, Thompson yes, Folk yes, Davis NO. Again a discussion on the Police. At this time Davis changed her vote and voted yes.

The following bills presented for consideration. At this time motion by Barnes that the Brewer bill of \$ 12400.50 be held aside and voted on separtly. Seconed by Davis. All voted yes.
