Dear Mr. Kelley:

It was and remains the position of the Amanda Village Council that Kenneth Stoneburner should be able to develop properties owned by him in the G. Simon's Addition, Amanda, Ohio. Concomitantly, Amanda Village Council adheres to the belief that certain right-of-ways in the vicinity of said Stoneburner properties, heretofore undeveloped, should remain as such, at least if development would result in the necessary expenditure of public funds. Recognizing the desire of Kenneth Stoneburner nonetheless to improve his properties, Amanda Village Council agrees to the following:

The right-of-ways designated on the Village Plat as Fredericks Street and Franklin Street, so far as they abut Stoneburner's properties, can be opened to public traffic provided the following conditions are met.

The streets at issue are to be constructed according to certain specifications. These specifications are to be recommended to Amanda Village Council by Blazer Materials or some other comparable contractor of Mr. Stoneburner's choosing, subject to Amanda Village Council's approval. Recommended specifications are to be based upon terrain and soil quality considerations. Specifications must be such that in the opinion of the recommending contractor the finished street will not be the cause of general dissatisfaction for adjoining propertyholders, present and future.

Amanda Village Council imposes the above requirement as it recognizes the Village's responsibility to maintain and repair improved public right-of-ways, such as these at issue will become.

Additionally, Amanda Village Council agrees to allow the right-of-way, running north and south from Franklin to High Street, immediately to the west of lots #143 and 144, to be opened to the public in the form of an alley. Again, specifications are to be

recommended by an independent private contractor, subject to Council's approval, and are to be such that will result in a relatively trouble-free public right-of-way to be maintained by the Village.

Any and all costs and any and all liabilities are to be borne by Mr. Stoneburner, or his successor in interest; and the Village of Amanda is to be free and unaccountable for any expense whatsoever, including but not limited to the cost of intersections, the cost of surveys, and litigational expenses and/or damages incident to defects in the Village's title to the right-of-ways at issue. Additionally, the cost of obtaining specifications as above-described, is to be borne by Mr. Stoneburner.

It is to be emphasized that no cost is to be incurred by the Village consequent to the development of the Stoneburner properties. Village Council has assumed the position that the Village is without funds necessary to the improvement of these streets and that the Village Council is under no obligation to necessarily expend funds for their improvement.

It is the Village Council's purpose, in setting forth its position, to allow Mr. Kenneth Stoneburner to make reasonable use of his property. It is hoped that this can be accomplished under the above-stated guidelines.

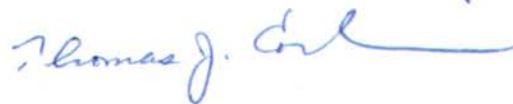

This would involve developing Fredericks Street north to Franklin Street, Franklin Street west to West Alley and West Alley to High Street. Mr. Stoneburner agreed that Lot #144 must be cut off to allow trucks the use of West Alley and Franklin Street. Once the specifications for developing these streets have been met, within a reasonable timetable, the Village of Amanda would be responsible for future maintenance. Councilmen will require a written statement containing specifications, timetable and means by which Mr. Stoneburner intends to proceed.

The water issue was then discussed and Council decided that the village will provide sufficient water for the consumer's use and that the cost of this extension should be resolved according to Ordinance 3-53 passed October 1, 1953, titled An Ordinance Providing Regulations Governing the Service and Use Provided by the Amanda, Ohio Municipal Water Works System.

*Solicitor Corbin mentioned having an agreement between future buyers and Mr. Stoneburner that would bind them with Ordinance 3-53 but Attorney Kelley did not agree.

Council requested a written statement agreeing to these main issues. Attorney Kelley is to provide this by June 1st or shortly thereafter. Then Mr. Betz may be approached regarding the removal of his fence.
