Section 2. Section 4. That the Clerk-Treasurer is hereby authorized and directed to issue a voucher for the payment of the sum of \$125.00 dollars to the Ohio Municipal League for membership for the Village of Amanda for the period of January 1, 1982 to December 31, 1982 inclusive, payable from the General fund.

Section 5. That upon request of the Mayor, the Clerk-Treasurer is hereby authorized and directed to issue a voucher for the annual payment, in advance, of dues to The Ohio Municipal League at the beginning of each calendar year thereafter in the amount fixed in accordance with the Constitution of The Ohio Municipal League, when and as said sums shall have been appropriated for such purpose.

Section 6. That this Resolution shall take effect and be in force from and after the earliest period allowed by law.

RESOLUTION AUTHORIZING THE EMPLOYMENT OF SPECIAL LEGAL COUNSEL IN THE FUNDING OF \$33,000 OUTSTANDING FIRST MORTGAGE WATERWORKS REVENUE BONDS OF THE VILLAGE OF AMANDA, OHIO, WITH THE PROCEEDS OF U.S. TREASURY OBLIGATIONS.


WHEREAS, this Council desires to undertake the requisite proceedings to consummate a plan for funding \$33,000 outstanding First Mortgage Waterworks Revenue Bonds of an original issue of \$90,000 of said revenue bonds dated November 1, 1952, maturing serially through 1992 (herein the "Obligations"); as outlined by The Cincinnati, Ohio, who have indicated the feasibility of said plan of funding of the outstanding Obligations with U.S. Treasury Obligations at a substantial interest cost savings to the Village;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Amanda, Fairfield County, Ohio:

Section 1. That this Council proposes to pursue the plan of funding the \$33,000 First Mortgage Waterworks Revenue Bonds of the Village of Amanda, dated November 1, 1952, as outlined, and in order to consummate said plan, Messrs. Peck, Shaffer & Williams, Cincinnati, Ohio, are hereby designated special legal counsel, to prepare the necessary legislation, documentation and other proceedings, in cooperation with the Village Solicitor, to consummate the funding of said outstanding Obligations and the defeasance of the lien thereof on the properties and revenues of the municipally owned waterworks system and facilities.

SECTION 2. That this Council hereby finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of the Council, and that all deliberations of the Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Revised Code.

SECTION 3. That this resolution shall take effect upon its passage.

WHEREAS, each of the above named institutions making application for public moneys of the Village of Amanda has agreed, pursuant to Section 135.18 of the Revised Code, in consideration of the award of public moneys, before receiving the initial or any subsequent deposits, to pledge to and deposit with the treasurer of Village of Amanda as security for the repayment of all public moneys of Village of Amanda to be deposited in the institution during the period of designation pursuant to award, eligible securities of aggregate market value equal to the excess of the amount of public moneys to be at the time so deposited, over and above such portion or amount of such moneys as is at such time insured by the Federal Deposit Insurance Corporation or by any other agency or instrumentality, of the federal government, or surety company bonds which, when executed, shall be for an amount equal to such excess amount;

(A) Sections 135.03 and 135.07, R.C. provide that no eligible institution shall receive or have on deposit at any one time public moneys in an aggregate amount in excess of thirty per cent of non-public moneys on deposit as shown in its latest report to the superintendent of banks or comptroller of the currency.

(B) No eligible institution shall be required or permitted to receive and have at any one time a greater amount of deposits than that specified in the application of such depository. See Sections 135.04 and 135.07, R.C.

(C) Section 135.04, R.C., provides that any institution mentioned in Section 135.03, R.C., which has an office located within the territorial limits of the subdivision is eligible to become a public depository of the inactive and interim deposits of public money of the subdivision.

An institution located outside the subdivision may be awarded the inactive or interim funds only under the following circumstances:

1. In case there is no eligible institution which has an office located within the territorial limits of the subdivision;

2. In case there is not more than one eligible institution which has an office locataed within the subdivision;

3. In case only one eligible institution applies for designation as a public depository of the inactive or interim deposits of the public moneys of the subdivision;

4. In case the aggregate amount of inactive or interim deposits applied for by such eligible institutions is less than the aggregate maximum amount of such inactive or interim deposits as estimated to be deposited pursuant to Sections 135.01 to 135.21, inclusive, R.C.

(D) Section 135.07 R.C., provides that the governing board shall award the inactive deposits of public moneys subject to its control to the eligible institution or institutions offering to pay the highest rate of interest on such deposits permissible at the commencement of the period of designation, in the amount as to each, specified in the application of the institution therefor. If two or more eligible institutions offer to pay the same permissible highest rate of interest on the amounts specified by the application, which in the aggregate exceed the estimated amount to be deposited at the beginning of the period, or the maximum amount thereof subject to deposit at any time during such period, the inactive deposits shall be divided and awarded among such eligible public depositories in proportion to their respective capital funds. If the aggregate amount of inactive public deposits as specified by application made therefor by the institution offering to pay the next highest permissible rate of interest thereon is less than the amount of public moneys to be initially so deposited, or the maximum amount required to be deposited during the period, as so estimated, the board shall award the remainder of such active deposits to the eligible institution offering to pay the next highest permissible rate of interest thereon in the amount specified in its application. If the amounts so specified in the applications of two or more institutions offering to pay the same next highest permissible rate of interest are in the aggregate in excess of such remaining estimated or probable amount to be so deposited, then such remainder shall be divided among and awarded to each of such institutions in proportion to their respective capital funds. In case the aggregate amount of inactive public deposits specified in the applications made therefor is less than the public moneys therof to be initially deposited or the maximum amount required to be deposited during the period, as estimated by the board, such governing board may invite applications for the

excess amount to such eligible institutions offering the highest permissible rate of interest therefor.

(E) Section 135.13, R.C., provides that "Inactive deposits shall be evidenced by certificates of deposit, each of which shall mature not later than the end of the period of designation, and may provide on its face that the amount of such deposit is payable upon written notice to be given a specified period before the date of repayment."

(F) Section 135.09, R.C., provides that interim deposits may be awarded by the treasurer or the governing board as interim moneys become available and shall be for certain maturities of not less than thirty days nor more than one year.

(G) Section 135.09, R.C., provides that the treasurer or the governing board shall award interim deposits of public moneys to the eligible institution or institutions which offer to pay the highest permissible rate of interest on interim deposits.

(H) Section 135.13, R.C., provides that "Interim deposits shall be evidenced by certificates of deposits maturing in thirty or more days but in no event more than one year from date of deposit."

(I) Section 135.04, R.C., provides that any institution mentioned in Section 135.03, R.C., which has an office located within the territorial limits of the subdivision is eligible to become a depository of the active funds of the subdivision. An institution located outside the limits of the subdivision may be designated as the depository of the active funds only if the aggregate amount of active deposits of the public moneys of the subdivision applied for by the eligible institutions located within the subdivision is less than the aggregate amount to be deposited as such as estimated by the governing board.

(J) The governing board is authorized at any time during the period of designation to request new bids for interim deposits from eligible institutions, upon a determination by resolution that the applications for interim deposits in force no longer reflect prevailing interest rates when the treasurer or governing board consider that the terms of the applications for interim deposits no longer reflect prevailing interest rates.

(K) The governing board shall award the first twenty-five thousand dollars of the active deposits of public moneys subject to its control to the institution qualifying therefor on the basis of the operating needs of the subdivision. The governing board shall award the active deposits in excess of twenty-five thousand

dollars to the eligible institution or institutions applying or qualifying therefor in proportion to their respective award quotas.

The award quota shall be determined by dividing the capital and surplus into the number of its permanent offices wherever located to obtain the active fund quota of that institution. The active fund quota so determined shall be multiplied by the number of permanent offices such institution maintains in the subdivision and the result shall be the award quota for that institution in the subdivision. The term "permanent offices" as used in Section 135.04, R.C., "shall mean the principal office and branches not including intermittent branches." See Section 1101.01 (D) of the Revised Code for a definition of branch offices.

Section 1101.01 (P) of the Revised Code provides that "Intermittent branch" means a branch at which a bank receives money or its equivalent for deposit on not more than three days a week at a given location, is housed in either a building or a mobile facility, and has been approved by the superintendent."

## RESOLUTION OF THE CITY/VILLAGE OF AMANDA

A Resolution Endorsing the Report of the House Public Utilities Committee and Urging Implementation of its Recommendations; Endorsing H.B. 964, H.J.R. 41 and S.J.R. 25 and Urging their Enactment, and Declaring an Emergency.

WHEREAS, On March 2, 1982, the House Public Utilities Committee of the Ohio General Assembly, Representative Ronald James Chairman, adopted a report regarding the Gas Purchasing and Pricing Practices of Columbia Gas of Ohio, Inc., and on April 7, 1982, Representatives Benny Bonanno, R. James, Malott, Camera, and Bowers introduced H.B. 964 to implement the recommendations of that Report;

WHEREAS, Representative Bonnano, Mahnic, Mallory, R. James, Stinziano, Locker, Colonna, Jones and Orlett have introduced H.J.R. 41 and Senators McCormack, Schwarzwald and Valiquette have introduced S.J.R. 25 in the Ohio General Assembly to inform the President, Congress, and the Governor of the legislature's strong opposition to all plans for an acceleration of the deregulation of natural gas prices;

WHEREAS, the City/Village of Amanda and its citizens are served by Columbia Gas of Ohio, Inc., and according to a recent Consumers' Counsel survey, Columbia's rates are higher than those of Ohio's other major gas utilities;

WHEREAS, customers of Columbia Gas have experienced large increases in their gas bills, paying approximately 35% more for gas during the winter of 1981-82 than during the previous winter heating season, with such increases having had a particularly severe impact on senior citizens, those on fixed incomes, and low income households, having drained the budgets of schools and businesses, and having placed a heavy burden on all Ohio consumers;

WHEREAS, Columbia Gas bills are composed of two types of components: the base rate which is set by municipal ordinance or the Public Utilities Commission of Ohio (PUCO) and is not uniformly regulated; and the gas cost recovery rate, controlled by the Federal Energy Regulatory Commission and the PUCO, which jumped 32% from September 3, 1981 to March 8, 1982;

WHEREAS, the City/Village of Amanda is paying one of Columbia's 742 different base rates, and the 646% variation from Columbia's lowest base rate in the New Albany unincorporated area to its highest in Stafford demonstrates the existence of significant price discrimination;

WHEREAS, such variations in base rates are in part attributable to specific ratemaking problems including Columbia's opposition to uniform rate negotiations, Columbia's failure to provide even basic cost of service and rate of return information to communities with which it negotiates, and the large number - 33 in the first 3 months of 1982 - of different applications for rate increases filed at the PUCO by Columbia Gas;

WHEREAS, Columbia Gas Transmission Corporation has passed through Columbia Gas of Ohio, its sister company, disproportionate increases in gas costs in comparison to other gas pipelines;

WHEREAS, the City/Village of Amanda is in agreement, in principle, with the recommendations of the Report of the House Public Utilities Committee on the Gas Purchasing and Pricing Practices of Columbia

Gas, H.B. 964, H.J.R. 41, and S.J.R. 25 which would help secure fair and reasonable rates for customers of Columbia Gas of Ohio, Inc.; and


WHEREAS, the ratemaking practices of Columbia Gas are unreasonable and require state action at the earliest possible time;

THEREFORE BE IT RESOLVED by the Council of the City/Village of Amanda in the County(ies) of Fairfield and State of Ohio:

Section 1. That the City/Village of Amanda endorses the Report of the House Public Utilities Committee on the Gas Purchasing and Pricing Practices of Columbia Gas and respectfully urges that its recommendations be adopted and carried out with all deliberate speed, endorses H.B. 964, H.J.R. 41 and S.J.R. 25 and respectfully urges their immediate enactment.

Section 2. That the Clerk of Council is hereby directed to forward copies of this Resolution to Governor James Rhodes, Speaker Vernal Riffe, Representative Ronald James, Representative Benny Bonnano, President of the Senate Paul E. Gillmor, Senator J. Timothy McCormack, the State Representative and Senator representing this district, Ohio Consumers' Counsel William A. Spratley, and the Public Utilities Commission of Ohio.

Section 3. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City/ Village of Amanda, and shall become immediately effective at the earliest time permitted by law upon its adoption as an emergency measure.





## RESOLUTION OF THE CITY/VILLAGE OF AMANDA

Opposing the Accelerated Deregulation  
of Natural Gas, Opposing Price Increases  
for Old and Intermediate Depth Gas,  
Endorsing HR371 and SR331, and Declaring  
an Emergency

- WHEREAS, the City/Village of Amanda and its citizens are served by Columbia Gas of Ohio, Inc, which receives gas primarily from its sister company, Columbia Gas Transmission Corporation, the nation's second largest purchaser of deregulated and partially deregulated gas;
- WHEREAS, the Natural Gas Policy Act of 1978 (NGPA) provides for the partial and gradual deregulation of natural gas prices in a manner intended to ease the burden on consumers of such a transition;
- WHEREAS, the Administration of President Ronald Reagan has announced support for the accelerated and total deregulation of interstate sales of natural gas;
- WHEREAS, the Federal Energy Regulatory Commission has under consideration price increases for gas from wells drilled prior to 1977 (old gas) and intermediate depth gas;
- WHEREAS, 226 U.S. Representatives have introduced HR371 and 31 U.S. Senators have introduced SR331 in Congress opposing the accelerated deregulation of natural gas;
- WHEREAS, the Energy Action Foundation has identified the cost to industrial users of natural gas nationwide as an additional \$237 billion during the next five years under immediate deregulation;
- WHEREAS, a U.S. Department of Energy analysis has estimated that the overall inflation rate would increase 2.4% and the unemployment rate would increase .7% during the first full year of complete deregulation;
- WHEREAS, the additional costs of deregulation would be passed through to consumers in the gas cost recovery (GCR) portion of their bills, Columbia Gas has already projected 20-25% annual increases in gas costs under the present system of regulation, and deregulation could double the size of these increases adding hundreds of dollars to the annual gas bill of a typical Columbia customer;
- WHEREAS, Columbia Gas of Ohio, Inc., the Public Utilities Commission of Ohio, and the Ohio Consumers' Counsel oppose accelerated deregulation of natural gas;
- WHEREAS, contracts now being signed for gas from wells already deregulated under the NGPA include prices as high as \$9.00 per thousand cubic feet (mcf) and costs substantially above the cost of alternate fuels;
- WHEREAS, accelerated decontrol of natural gas would have a particularly severe effect on Ohio's agriculture and key industries, draining billions of dollars and tens of thousands of jobs annually from the state, would have an especially harsh impact on the elderly, those on fixed incomes, and low-income households, and harm all Ohio consumers; and
- WHEREAS, the imminent threat of decontrol of natural gas prices requires our immediate action;
